


## Day 1 T.A.G. Time Alone with God

You have been called upon to take part in an amazing task... you must decide the TRUTH. You must decide beyond a reasonable doubt what is TRUE and what is NOT. You have been called upon to fulfill an amazing responsibility as a jury member in the trial of the century, more than that, the trial of the last 20 centuries. Are you ready?



"I have investigated all the reports in close detail, reports handed down by the original eyewitnesses... so that you can know beyond a shadow of a doubt the reliability of what you were taught" These are the words of a doctor named Luke. He wrote them around 61 AD- that's 1,946 years ago. But today his words still have a huge impact on anyone who reads the Bible.

So what's this trial about? What if over a thousand years ago there was a courtroom in which Luke had to prove his Gospel was true? Now, you and I both know this really didn't happen; there never was a trial, but... what if there was? This week you will be in that courtroom, you will witness Luke's testimony, will learn firsthand what Luke teaches us about Jesus.

Let's look at that letter again--

*Many have undertaken to draw up an account of the things that have been fulfilled among us, just as they were handed down to us by those who from the first were eyewitnesses and servants of the word. Therefore, since I myself have carefully investigated everything from the beginning, it seemed good also to me to write an orderly account for you, most excellent Theophilus, so that you may know the certainty of the things you have been taught.*  
*Luke 1:1-4*

Even if Luke never really went on trial, he was prepared to! He told us everything we needed to know!

### Who's this Luke guy?

Although Luke was a doctor, he really did investigate Jesus' life story. He never met Jesus face-to-face, instead Luke learned everything he could about Jesus from all of the people (real life witnesses) that had seen Jesus in person. For Luke, it all started one day when a guy named Paul told him Jesus' story. Years later, Luke wrote his letter to tell others about Jesus. Later on, Luke wrote a second letter to Theophilus, we call it the book of "Acts." It tells about the amazing journeys he and Paul experienced together.

### Who else wrote about Jesus?

In your Bible, there are many books that tell us things about who Jesus is. The Gospels: Matthew, Mark, Luke, and John tell us the most about Jesus. Although many others who have written about Jesus, these four letters were considered the best of the best, because God told Matthew, Mark, John, and LUKE what they should tell us about Jesus.

### Who are the eyewitnesses?

The word Luke originally used for eyewitness means "to see for yourself." More than anything, Luke wanted you and I to read exactly what the eyewitness told him about Jesus. He hoped that by reading his letter, we could know exactly who Jesus was! That's why he "investigated" Jesus' story for us. That's why he talked to so many eyewitnesses. Luke wrote all of this for you, me, and Theophilus.

## So, who was Theophilus?

Theophilus was a very important man. That's why Luke calls him "most excellent Theophilus." Most people who study the Bible think the two of them must have been pretty good friends. That's why Luke wanted him to know the truth about Jesus. Luke may have worried that his friend was having a problem believing all of the amazing stories about Jesus.

You're the jury, you get to decide. Are you ready?

### Questions:

1. How would you feel if a story you wrote was put on trial? How would you feel if people called you a liar?
2. How can we know that Luke wrote the truth about Jesus' life?
3. How would your life be different if you saw Jesus with your own eyes? How?
4. As a member of the Jury, what will it take for you to believe Luke's gospel?



### Deposition #1

This deposition contains a "just pretend" interview with the real boy that helped feed "the 5,000."  
--Judge Les Knotebe, Luke (Defense), and Ms. Sorry (Prosecution) present.

### READ EXHIBIT H PAGE 8 in your Luke's letter file! (9:10-26 and other text mentioned below)

Judge: "If I lived here, I'd be home now, but I don't, so I'm not... do we have a witness!?"

Luke: "Did you and I ever talk about your encounter with Jesus?"

Boy: "Yes, we talked a few years ago, I remember you wanting to make sure you had the correct amount of fish and bread, and other details for your story."

Ms. Sorry: "If that's true, Luke why didn't you write about the hundreds of fish and thousands of loaves of bread you brought with you? Or should I say your parents sent with you! Isn't it true that your mom and dad run a fish and bread stand? Obviously, this was a blatant attempt at personal gain by both the boy and this Jesus character."

Boy: "No that's not right... well, yes they do. But..."

Ms. Sorry: "So I'm right, this story is nothing but an advertisement for your parent's fish restaurant?"

Boy: "Hardly, my mom had just packed me a lunch. Sure, she said if I saw Jesus, I might offer him a loaf or two. She had heard about him and wanted him to try her homemade Jersey Rye."

Luke: "So, what happened when you gave him your fish?"

Boy: "It was a miracle!"

Ms. Sorry: "I am sure it was. It's a miracle that Jesus fell into your trap and advertised for your family restaurant in front of 5,000 unsuspecting citizens!"

Boy: "No, it was nothing like that, how in the world do you think I could bring that much food to that mountain side? At most we could deliver to a party of twenty, and our Ox was in the shop that day, he'd thrown a shoe, that's how I was able to go to the mountainside in the first place- Mom gave me the day off and I..."

Ms. Sorry: "So, you admit it, you do deliver... interesting..."

Boy: "No, it was a miracle... thousands of men, women and children were fed by my two fish and five loaves... TWO FISH, FIVE LOAVES!"

- Luke: "Wait just a 60 second minute, here. Did your parents' restaurant get any more business out of this event?"
- Boy:** "**No, actually, from that day on it was a really slow week for us, everyone had gotten so full eating at the hill, they didn't feel like eating fish again so soon.**"
- Judge:** "*Just a regular kind of minute here ... My mom always told me that I could give a man a fish and he could eat for a day, or I could teach a man to fish and he will eat for a lifetime, My Mom never said anything about some silly restaurant or any boy's lunchbox on some hillside... Rule number #4 I am always right, so that means my mom must always be right too!*"
- Boy:** "**Sir, I am not sure you understand, Jesus feeding all of those people wasn't even the most amazing thing I saw or heard that day, it was what Peter, one of His disciples said...**
- Judge:** "*I have had enough of this, something more amazing than feeding 5,000 people... this is madness, next Witness!"*

### Deposition #2

This deposition contains an interview with Peter, one of Jesus' Disciples, and one of "The 5,000."

- Luke: "Peter, you spent a lot of time with Jesus, yet when you and I talked about your relationship with Him, you said there was one day in particular, one day in his early ministry that really stuck out to you."
- Peter:** "**Yes, that was one of the most amazing moments in my life, the first time God had ever said anything through me. It was right after Jesus fed the 5,000.**"
- Ms. Sorry: "Judge, I believe you have already made a decision about this feeding rumor!!"*
- Judge: "All your arguing about food is making me hungry- I decree, there shall be no more talk of food!"
- Luke: "Yes, Judge, no more talk of food. So, what happened next Peter?"
- Peter:** "**It was the day I first realized Jesus was the Son of God.**"
- Luke: "You realized?"
- Peter:** "**Good point Luke. Actually God told me or said it through me- its hard to say exactly!**"

*Ms. Sorry: "HEARSAY!!"*

- Judge: "Mrs. Sorry, I just ate my last Hershey bar, or I would have shared."
- Ms. Sorry: "No your Honorableness, what I am saying is that there is no way to prove that God actually told Peter anything! This is hearsay- we only have this witness' word- God is not on the stand to tell us what he said or did not say to or through Peter!"*
- Luke: "There is also no way to prove that God didn't tell him that Ms. Sorry."
- Judge: "All your arguing is making me hungry- Bailiff please fetch me a candy bar... and apparently one for Ms. Sorry as well."
- Peter:** "**But, Your Honor, God did reveal to me who Jesus was... this is a bigger concern than some candy bar!**"
- Judge: "Yes, as I just said, two candy bars."
- Peter:** "**This is about the Son of God coming to earth to save us all from our sin! This is HUGE!**"
- Judge: Yes, I am sure my good man. A super-size Hershey would have been much better than the little snack size bar I had... by the way, do you happen to have a Banana or some American cheese?
- Luke: "Your Honor, can we just get back to this witness' testimony please?"
- Peter:** "**When God revealed to me that Jesus was His son, that Jesus was the Christ, it was mind blowing! Especially that day, and even today I am not sure I fully understand it, it means that God had sent a Savior, our Savior into the world.**"
- Judge: "He's must not be much of a saver... I never got any of that fish... didn't save me any."
- Peter:** "**Your honor, you're missing it. He, Jesus was the Savior. He was the chosen one. He was God 100% and man 100%. He was the only one who could save the world, who could save us from our own sin.**"

**And for some reason, I was chosen to be the first disciple to say those words out loud. I was the first to actually know who he was... not just take a guess at who he was as all the other people on that hill were doing that day."**

Judge: "But what does this have to do with my being hungry now?"

**Peter:** "**Nothing sir, it's much bigger than that.**"

Judge: "I thought so. The witness is dismissed."

As you can see, this Luke fellow has written quite a story or two. The question before you is how in the world can you agree with a boy with advertising aspirations and a man who hears God in his head yet doesn't have the decency to bring me a snack. Hopefully these affidavits will help you determine the truth about this letter Luke wrote, the so-called story of Jesus' life.



Containing a "just pretend" interview with the real Pharisees in the "Crowd of many Thousands"

Judge: "Save the cheerleader, save the world... Do I have a witness?"

Ms. Sorry: "I would like to call a Pharisee that attended the Crowd of Many Thousands."

Pharisee: "Why thank you most honored prosecution..."

Pharisee: "My apologies sir, I was simply complimenting Ms. Sorry."

Pharisee: "So Jesus comes out. You would think the guy would start speaking to us? Yet, he didn't. He was just talking to his own followers, as if we weren't even there."

Ms. Sorry: "Sounds quite rude. What did he say?"

Pharisee: "This guy starts calling the four of us names, right there in front of all those people. He said we were full of yeast. Can you believe that? Yeast!"

Judge: "I have heard a lot of name calling in my day... but the nerve to call someone "yeast," well that's just... completely uncalled... um. I don't get it?"

Pharisee: "We didn't either, honestly, we were all a bit confused. Last time I checked, yeast was used to make bread rise for baking. Making bread fluffy is a good thing, right? But after he called us yeast he got really mad. He told all his pals that my friends and I should not be trusted. He told them that he planned to reveal to everyone everything that we had ever done-- especially the bad stuff! I know I'm not perfect

**your honor, but that man threatened my livelihood. My personal business... I mean ministry. I started to worry that he must have been following us around listening to our plans... this man threatened to repeat everything we said!**

*Ms. Sorry: "So, Jesus was a spy?"*

Luke: "No, No, No. Jesus was saying that once we die, our lives will be revealed. He wanted us to know that the way we live is important. God wants us to do good things, he's not a spy. He loves us! He just wants the best for us. Jesus was worried that his followers would get caught up in hypocrisy-- in the way the Pharisees lived their lives. This man and the other Pharisees use other's faith in God for their own personal power. Jesus just wants all of us to focus on growing in our relationship with God"

**Pharisee:** <cough, cough> "Well, I don't know about all of that. I just remember Jesus saying that he knew how many hairs were on my head. What an odd threat! How could he know that without sneaking into my house at night and counting? We just came to hear him talk, and the man starts threatening us. It's not right. Then he starts on about birds... again, it was all so very odd."

Luke: "Your honor, may I point out that this Pharisee has retold this event exactly as it appears in my Gospel. He simply does not like what Jesus said, because his lifestyle was very much threatened by Jesus' teachings. On the other hand, I, and many believers like me, thought Jesus was brilliant, his teaching incredible: God loves us more than the sparrows! He cares for you, your Honor! He simply has expectations for us and wants us to learn to follow him. Putting ourselves first as this Pharisee did and continues to do, falls short."

Judge: "Hmmm, I see. Yet Luke, have you forgotten... rule number five, no singing, and birds sing. Dismissed."

#### **Read More:**

Read this passage, especially the last part. You will find the word "acknowledge" it means to accept- to know that something or someone exists. Who is Jesus going to tell the angels about?

#### **Questions:**

1. The Pharisees often put themselves above all the others who believed in God. They acted like everything they did was just fine, and the rest of the world was not as good as them. Yet they were very sinful in their attitude towards God. Have you ever met anyone like that?
2. Have you ever lived like a Pharisee?
3. Not only does God know you... he knows everything about you. What does it mean to you when God says you're more important than the sparrows?

Judge: "If cow is beef, and pig is pork, why is chicken just chicken? Do we have a witness!?"

Luke: "Mother from Nain, did you and I ever talk about your encounter with Jesus?"

Woman: "Yes, we talked a few years ago. I remember you really wanted to make sure you understood exactly what happened to my son. I remember struggling with some of the medical terms you were using."

Luke: "Oh, I'm sorry, sometimes being a doctor makes it difficult to communicate. Was there any term in particular that you struggled with. Any term that you need me to better define for you?"

Woman: "Yes, 'dead' was a problem."

Judge: "My dear woman, you must know that dead is defined as... well DEAD of course, everyone knows that."

Woman: "I know that you're Honor. That is to say: I thought I knew that. Death has had a huge impact on my family. It was the summer of '16 that my husband died. It was a terrible ordeal; my son had just started to learn our family trade. My husband was a butcher; the whole town knew and loved him. But one morning he didn't wake up. He was dead. And now my son had to learn the family business on his own, we had to go on, on our own.

I don't know if a mother has ever been as proud as I had been of my son- he was just a teenager don't you know. Even more importantly, he had become every bit of the man my husband was. Just like my husband he was the kind of man people loved to be around.

But, as the funeral was about to end, the whole town and I walked my son out to the hole we had dug next to my husband... to bury him."

**Woman:** "Suddenly, this man appeared. Oddly enough, he was approaching town with a crowd nearly as large as the crowd I was apart of. Then this man walked up to me, he gently put his hand on my shoulder and said, 'Don't cry.' It was so odd. All of us sort of froze, his eyes seemed so kind, for a moment I almost forgot the funeral. Not only did he seem to understand who I was, but also what I was going through. Then he walked over the coffin, touched it and said, "Young man, I say to you, get up!" at that moment, death was redefined for me. Dead was no longer DEAD."

Luke: "Could you tell me who that young man is sitting behind you?"

**Woman:** "Yes Luke, that's my son Max."

**Judge:** "My dear woman, you must be mistaken, there must be a misunderstanding here- dead is defined as DEAD for a reason, there is no way..."

Luke: "What was the name of that man, the one who brought your son back to life?"

**Woman:** "Jesus."

4. What is the difference between using Jesus as fire insurance- as a get out of death free card – and having a personal relationship, actually a friendship with him?

Judge: "Time flies like an arrow, fruit flies like a banana... do we have a witness!?"

Luke: "Have I ever talked to you about your encounter with Jesus?"

Fisherman: "Yes, we talked a few years back, I remember you asking about what happened with Peter that first day we all met Jesus."

Luke: "Please tell the court about your encounter with Jesus?"

Fisherman: "Well, the story really starts the night before. See, Simon, the Zebedee brothers, a few other hired hands like myself was out fishing together. We all worked for the same guy, Frank, he ran *Franks Fish Market* downtown. Well, it was awful. One of the lousiest nights of fishing we'd had in years. We tried our no miss spots- nut'en, new spots- nut'en. Betcha we threw our nets in an' pulled them out a hundred times and we didn't catch a thing. It was ugly. Frank was gonna be mad.

So we come back to shore and cleaned our nets and put everything away. Let me tell you, there ain't nut'en more discouraging then washing the nets the next morn'in after come'n up empty.

**Judge:** "*Luke, my Dad always said, 'Give me ambiguity or give me something else.' But, maybe this Jesus you wrote about, is the something else my Dad was talking about. Could there really be someone else?*  
*Well, ah, <cough, cough> court adjourned!"*
